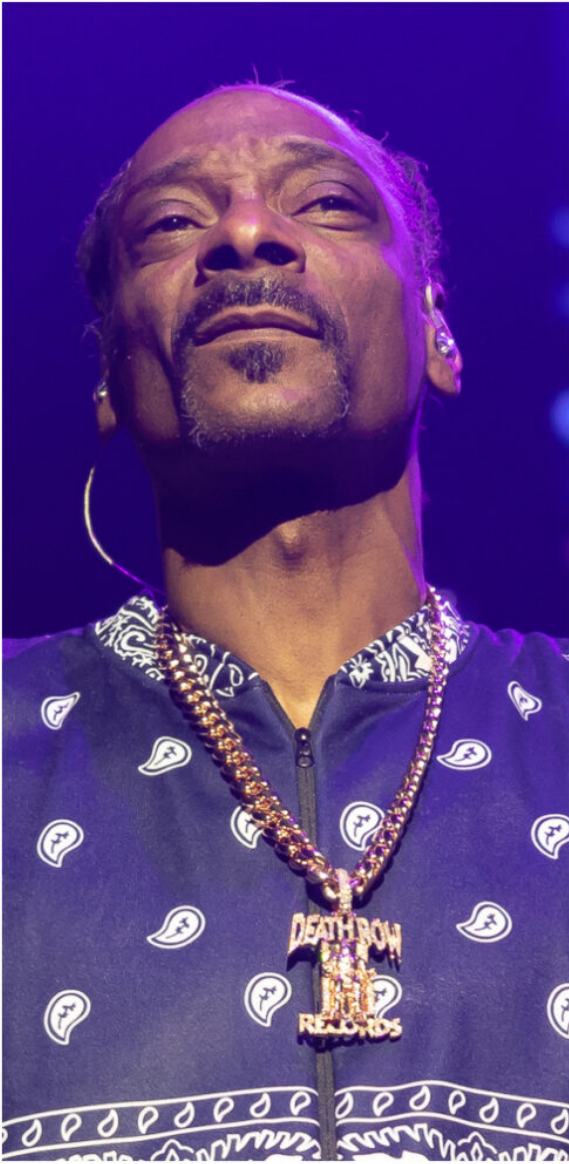

Jr.'s March On Washington



Motown Records has released Martin Luther King Jr.'s March On Washington digitally for the first time. *The Great March On Washington* was recorded on August 23, 1963, on the steps of the Lincoln Memorial. Dr. King delivered his famous I Have A Dream speech during the March On Washington for Jobs and Freedom.Â

The digital release of The March On Washington coincides with TIME and executive producer Viola Davis inviting the public to go back in history with THE MARCH- a VR museum exhibit that recreates the March On Washington and allows visitors to experience the I Have A Dream Speech. The exhibit at the DuSable Museum of African American History in Chicago runs through November 2020. Additional locations will be announced and tickets can be purchased [here](#).Â
