R.I.P. Cissy Houston




Cissy Houston, gospel singer and mother of Whitney Houston, passed away on Monday at age 91. Houston, who was born Emily Drinkard, started her music career in 1938 when she and her sister Anne and brothers Larry and Nicky formed The Drinkard Four gospel group. Their sister Marie joined the group and the name was changed to The Drinkard Singers. Houston's sister Lee managed the group and later became the mother of Dee Dee and Dionne Warwick. The group performed regularly around Newark,

New Jersey, and after an appearance at the Newport Jazz Festival, they signed a deal with MCA Records and became the first gospel group to release an album on a major label. The group would experience some more changes in the lineup and become The Sweet Inspirations. They had a Top 40 hit in 1968 with "Sweet Inspiration" and became an in-demand backup group. Van Morrison used them on his iconic hit, "Brown Eyed Girl," and Jimi Hendrix, Elvis Presley, Dusty Springfield, George Benson, Wilson Pickett, Aretha Franklin, and Carmen McCrae were some of the artists that used The Sweet Inspirations in their recordings.

Houston started recording solo records in 1963 with the single "This Is My Vow." Her solo album, Presenting Cissy Houston, was released in 1970. Houston recorded four solo albums in the '70s and had a disco hit with "Think It Over." She was the first to record "Midnight Train To Georgia" in 1972, one year before Gladys Knight & The Pips made it a hit. Houston was in demand as a session singer and recorded with Paul Simon, Better Midler, Burt Bacharach, and Linda Rondstadt. She performed live with her band around New York City and Whitney would frequently join her on stage. In the 90s, she won Grammy awards for her gospel albums, Face To Face and He Leadeth Me. She recorded the duet "I Know Him So Well" with Whitney in 1987 and it appeared on Whitney's second album. In 2006, she recorded "Family First" with Dionne Warwick and Whitney for the Daddy's Little Girls soundtrack. BET did a tribute to Whitney Houston in 2012 after passing and Cissy performed "Bridge Over Troubled Water." The average pop culture historian has relegated Cissy Houston to being the mother of Whitney but she was a vocalist in her own right that made music listeners understand that a backup singer was just as important as the lead vocalist. Her work on Aretha Franklin's "Ain't No Way" elevated the song into an otherworldly listening experience and this is why Franklin made sure to have Houston on stage with her during their last television appearance together in 2014 on The Late Show with David Letterman. Houston paved the way for her daughter Whitney and numerous singers, especially those who showed their star power in a supporting role.

The 30th Anniversary Of Whitney Houston's Trip To South Africa Was Celebrated At 3rd Annual Legacy Foundation Gala



The 30th anniversary of Whitney Houston's trip to South Africa was celebrated at the Whitney E. Houston Legacy Foundation's 3rd Annual Gala. The foundation and Primary Music presented the event on Friday, August 9th, at the St. Regis Hotel in Atlanta, Georgia. Kevin Frazier of *Entertainment Tonight* and Pat Houston were the hosts, along with MC Jonathan Slocumb.



Whitney Houston was the first major recording artist to perform in post-apartheid South Africa. The show at Kings Park Stadium in Durban took place on November 8, 1994. Two subsequent shows were at Ellis Park Stadium, also known as Emirates Airline Park, in Johannesburg on November 12, 1994, which was filmed for an HBO special, and the final one at Green Point Stadium in Cape Town on November 19, 1994. Clive Davis, Honorary Chair and Chief Creative Officer of Sony Music Entertainment, opened the gala with a video message about Houston's historic trip to South Africa, her worldwide cultural impact on music, and her performance of "Home" on *The Merv Griffin Show* when she was 19 years old.



Musical director Kelvin Broughton led singer Yolanda Adams through a performance of Richard Smallwood's signature classic, "I Love The Lord," which Houston performed at each one of her concerts, and "Home," written by Broadway composer, the legendary Charlie Smalls, which is one of Adams' favorite songs performed by Whitney. Both of Adams' anointed performances received two standing ovations and left the audience wanting more. "Home" was also dedicated to South African special guest, Mirriam Solani Mazibuko, the director of the Orlando Children's Home in South Africa, who was the representative of this year's charity grant. Thirty years ago, Whitney extended a generous financial donation to them through her foundation.



In June of 2024, Pat Houston and key representatives of The Whitney E. Houston Legacy Foundation, along with board member Dr. Jacqueline Mohair, visited several places in Johannesburg that Whitney visited in 1994, including the Orlando Children's Home in Soweto. While there, the foundation team spent time with the children and young adult residents, and they performed a song. Pat Houston also made the presentation to Mazibuko, who is the charity grant representative.

In return, Mazibuko and her daughter were invited to attend this year's gala by Pat Houston. She and her daughter travelled to Atlanta and Mazibuko shared her story about the lifelong work and mission of the Orlando Children's Home. She also shared memories of a young Whitney, her beauty, her grace, her regalness, her extraordinary talent and her promise to return to the homeland. Mazibuko shared that Whitney promised her that she would return to South Africa.



Thirty years later, that promise was fulfilled, when Pat Houston and the foundation team returned to South Africa to visit Mazibuko and the young adults of the Orlando Children Home, not only to represent the foundation but also the Houston Family.

"Whitney would have wanted us to return to South Africa to represent her and commemorate this special time in history, says Pat Houston. "Whitney had many significant milestones and historic moments in her life and career, but her love for children, her love for South Africa and its people, and getting to know and spend valuable time with Nelson Mandela and his family meant everything to her. Nelson Mandela and that experience in South Africa changed and reshaped her life, furthering her commitment to continue her work with children and young adults. Whitney was a great example of the Bible scripture, Luke 12:48, 'To whom much is given, much will be required.'"



"I know we made Whitney proud. We helped to serve the foundation's mission and purpose in the global community. And the tree Whitney planted thirty years ago at the Nelson Mandela home, which is now named the Nelson Mandela Museum, is

a reminder to us and a symbol to continue the work in her name and legacy."



Whitney's brother and longtime duet partner and background singer Gary Houston also performed a medley of Stevie Wonder's classic songs, "Do I Do," and "Love's in Need of Love Today," and the finale performance of "We Can Touch The World" with Pat Houston and the Sauce background singers.




Additional performances included Gregory Sams and Denisia, the recent winners of The Whitney E. Houston Legacy Foundation's Cover Song Competition. Sams performed "Miracle," and Denisia performed her New Orleans-styled reimagined version of "I Wanna Dance with Somebody (Who Loves Me)." Both received The Whitney E. Houston Legacy Foundation 2024 Voice Awards.

The annual fundraiser also included scholarships for college students studying the arts at historically Black Colleges and Universities (HBCUs). This year's recipients were Donovan McClain and Saniah Wharton of Morgan State University in Baltimore, Maryland.









Whitney was the first major recording artist to perform in the newly unified, post-apartheid nation. She performed at Kings Park Stadium in Durban (November 8, 1994), Ellis Park Stadium, also known as Emirates Airline Park, in Johannesburg (November 12, 1994), which was filmed for the HBO Special, and the final performance was held at Green Point Stadium in Cape Town (November 19, 1994.)

Four-time Grammy Award-winning recording artist Yolanda Adams will be the headlining performer at this year's gala, with a special performance by Gary Houston, Whitney's brother and longtime duet partner and background singer, along with more surprises. The event will be hosted by Kevin Frazier of Entertainment Tonight and Pat Houston, president of the Whitney E. Houston Legacy Foundation. The Honorary Chair is Clive Davis, the legendary Rock and Roll Hall of Famer and Chief Creative Officer of Sony Music Entertainment.

Also performing are Gregory Sams and Denisia, the recent winners of The Whitney E. Houston Legacy Foundation's Cover Song Competition. The charity grant will be presented to Mirriam Solani Mazibuko, the director of the Orlando Children's Home in South Africa, which is one of the organizations that Whitney extended a generous financial donation to through her foundation thirty years ago. Last month, Pat Houston and team members of the Foundation traveled to South Africa to a few of the places that Whitney visited in November 1994, including the Orlando Children's Home, to spend time with the young residents there, where they prepared a presentation and performed a song.

Also, during that time, thirty years ago, Whitney initially planted a tree at the Nelson Mandela home, which is now named

the Nelson Mandela Museum. "Our trip to South Africa a few weeks ago was very fulfilling and emotional," says Pat Houston. "A few of us haven't been back to South Africa since 1994. Whitney would be proud to know that the Orlando Children's Home is still there and serving an important and vital purpose in the community. She would also be pleased about some of the substantial growth in the country in many areas. And she would be delighted to know that the tree she planted at the Nelson Mandela Museum is beautiful, still flourishing, and in a safe place, surrounded by love."
